## Prologue

The year 2020 was a special year for the International Federation for the Economy for the Common Good. (hereinafter referred to as the International Federation or IF for short) a special year in many respects. On the one hand, we were all surprised by the circumstances and effects of the worldwide Corona pandemic, which also massively affected the daily life of our association. Face-to-face exchanges have been reduced to a minimum and to online meetings which are the new standard. At the same time, it was the first full business year in which we gradually took over the business of the "Internationaler Verein zur Förderung der Gemeinwohl-Ökonomie e.V." (International Promoting Association = IPA), which was closed down at the end of the year. All contents and responsibilities were transferred to the International Federation and the entire contractual basis was and still is translated into English.

Furthermore, it was a very successful year for the Common Good movement. Not only that we were able to welcome two new national associations from Belgium and Luxembourg as new members of the Federation. We are also proud of the fact that the number of members and the number of regional groups grew by more than 30 %. One can even say that the crisis background of the global pandemic has probably contributed to the fact that more and more people worldwide are committed to making our world and our economy more sustainable. People are realising that the lack of biodiversity and the virus epidemic are directly connected. It is becoming clear that everything is connected to everything else and that the economy is part of the problem that we can fundamentally solve. The Economy for the Common Good offers the systemic approach for this. We are happy to see that more and more people around the world are committed to a common good economy. We are particularly happy about the strong development of our activists in Latin America. With the exception of a few countries, we are represented with activists on the entire continent. National associations have already been founded in Chile, Mexico and Ecuador. The ECG association in Argentina is about to be founded.

The global dissemination of the Common Good Economy is supported by the International Federation with a variety of projects and services. You will find a detailed overview of the individual activities in this annual report, which we would like to share with you.

All this is only possible thanks to your idealistic, financial and active support! We would therefore like to take this opportunity to explicitly thank you for your trust in the Common Good Economy and the Common Good Economy movement. Together we will make a good life possible for all!

# Annual Report 2020

The International Federation was founded on 29th September 2018 as the umbrella organisation of the international Common Good movement. Only national associations of the Common Good movement are admitted as full members. At the turn of the year 2020, it has eleven full members:

The board members of the Federation were elected at the annual general meeting on 04 April 2020. The executive directors are Bridget Knapper, Dr Heidi Kharbhih and Manfred Jotter. Their periods of office end with the Annual General Meeting in 2022.

### Purpose and scope of the Federation

As an umbrella organization, the International Federation is a Federation of bodies promoting the common good economy. The aim of the International Federation is to promote the cooperation of its member organizations, to form a platform for this and to create structures that enable synergies and make better use of potentials.

It is important that the Common Good Economy movement can emerge and be promoted in a participatory way according to the needs of its members and their regional circumstances. The purposes of the Federation according to its statutes are:

- the general promotion of democratic governance
- the promotion of civic engagement for non-profit purposes.
- the promotion of education, public education and vocational training.
- the promotion of science and research.
- the promotion of an international mindset, tolerance in all areas of culture and the idea of international understanding.
- the promotion of consumer advice and consumer protection

### Board meetings and general meetings

The Corona pandemic had a significant impact on the frequency and mode of our regular meetings and gatherings in 2020.

Board meetings took place a total of twelve times in the extended circle of the ECG Management Team (EMT) in mostly 3-to-4-hour online meetings. The Federation Members Council (FMC) meetings took place online a total of four times in 2020.

At the Annual Members Meeting for the 2019 financial year on 04.04.2020, the old Board was discharged. Bridget Knapper and Manfred Jotter were re-elected to the board, Dr Heidi Kharbhih was newly elected to the board.



### Development of the Common Good Economy 2020



The Common Good Economy movement is active in more than 30 countries as of 31 December 2020. There are over 36 regional and national associations. Of the 15 national associations, 11 are currently united in the International Federation of the ECG.

We are particularly pleased about the increasing spread in South and Central America as well as the first regional groups on the African continent. But also, in Asia there are the first active people who have joined together to form regional organizational groups. Worldwide, the Common Good Economy movement has more than 115 local chapters.

The total membership of all associations continues to develop very positively. Since the foundation of the founding association in Vienna/Austria, the membership figures of the associations worldwide have been rising steadily. This year, the increase of 30% is twice as high as in the previous year.

The Corona-related switch to predominantly virtual meetings require a technical infrastructure that was already in place and used at the International Federation in times before the pandemic. Online meetings and online conferences were already part of the 'normal' cooperation culture for the globally active IF before the pandemic. However, we have the impression that under the general compulsion for virtual exchange, the frequency of meetings and the overall exchange increased a lot. Larger meetings, such as the Delegates Assembly, but also the members' assemblies called FMC (Federation Members Council) also took place exclusively online.

In any case, the board meetings took place much more frequently but were shorter. As in the past, the Board met in the extended circle of the EMT. This means that they were complemented by the 2 or 3 representatives of the International Coordination Team / ICT, which is appointed by the Delegates Assembly of ECG. In 2020 these were: Gus Hagelberg, Christian Felber and Anke Schwind (until June 2020). We would like to take this opportunity to thank the ICT and its members for the constructive cooperation and for the great commitment that the members of the ICT have repeatedly brought to our joint deliberations.

The year 2020 was primarily characterized by the consolidation of the international Federation structures. The International Federation for the Economy for the Common Good e. V. was not entered in the register of associations until November 2019, so that after a short start-up phase the federation only became operational in 2020. The general task of the Federation for the entire financial year was to take over and transfer the international business, which in the past was carried out by the "Internationaler Verein zur Förderung der Gemeinwohl-Ökonomie e.V.".

Other important activities were the further development of the international strategy in cooperation with the strategy team and the establishment of the budget team to steer the participatory budget process for 2021.

Another challenge was and is dealing with the unsteady financial resources. Donations are only controllable to a limited extent and are not suitable for a steady and predictable financial supply. Here we have taken a big step towards greater predictability of financial resources through the adoption of the International Reconciliation of Finances.

The significant increase in membership of our affiliates led to an increase in our membership fees. In addition, we enjoyed a slightly increased inflow of donations, so that we were able to dispose of slightly increased income overall in 2020. Expenses were largely at the same level as the previous year, so that the association was able to build up reserves here to a modest extent.

In detail, our activities can be described as follows:

#### Quarter I – January to March 2020

- We commission Anke Schwind with the temporary consolidation and bundling of all ideas and activities on the topic of the ECG Academy. The aim is to get a comprehensive overview of all activities and to develop a concept for an international ECG Academy with different actors in different places and countries. The coordination should be handed over to the final coordinator/director of the future ECG Academy.
- Due to the Corona Pandemic, we decide to organize the annual general meeting of the IF the FMC online in April. The Assembly of Delegates, which was planned for summer 2020 in Sweden, has been cancelled. At the moment we do not know if we will be able to organize a face-to-face event in the summer.
- The IT migration project, which was originally supposed to be completed by the end of Dec 2019, has been delayed due to various data migration and handover issues. We successfully complete it in April 2020.
- The ECG adopts a general position on the anti-Corona measures. We support the measures, but also stress the importance of balancing all measures with citizens' freedoms.

#### Quarter 2 – April to June 2020

- The annual general meeting of the IF will take place on 04.04.2020. The board reports on the past financial year 2019. The responsible board is discharged. Pedro Olazabal leaves the board for family reasons. We would like to take this opportunity to thank Pedro once again for his very valuable work on the Board. In his place, Dr. Heidi Kharbhih is elected to the Board. Bridget Knapper and Manfred Jotter are re-elected to the board for another two years.
- Another FMC will take place on 02.05.2020. The main topic is a reflection on its scope and activities and the possibilities to improve cooperation. Some organizational measures will be decided that will improve cooperation both within the FMC group and between the ECG Management Team (EMT) and other ECG groups. Among other things, board members will always attend FMC meetings. EMT minutes will be made available to all FMC members and more exchange of ideas and issues (strategy, budget, projects) will be agreed.
- The "Internationale Verein zur Förderung der Gemeinwohl-Ökonomie e.V." decides to discontinue its activities at the end of the year. The tasks of the promotion association are to be taken over by the International Federation. The tasks and contracts will be gradually handed over to the IF during the year.
- We decide to translate the ECG Policy and to adapt it to current developments in this context.
- The audit tool is declared the core tool. In this way we ensure the coherent collection and documentation of the ECG balance sheets.
- We decide to organize the Delegates Assembly in July online. We have to reschedule at short notice. The additional costs caused by this, especially due to more complex moderation and technology, will be covered by the general budget.
- The IF participates in the GmbH Stakeholder Conference. It becomes clear that the entire area of economic services within the ECG needs to be reorganized. We mandate Heidi Kharbhih to start the Professional Services Project. The aim of the project is to take stock and reorganize the commercial services within the ECG.
- We decide to actively support the consultation of non-financial reporting to the EU institutions.
   We commission Better Europe BV to support and advise us in our lobbying work in Brussels.

#### Quarter 3 – July to September 2020

- Anke Schwind is leaving the EMT for personal reasons. We thank Anke for her constructive cooperation. Once again, we discuss and decide on the reallocation of our tasks and work priorities.
- The Assembly of Delegates takes place online in July. 97 participants and 60 delegates from 12 different countries discuss and decide on 9 submitted proposals. These include the adoption of a code of ethics for fundraising, the Common Good Charter and regulations on the transparency of ECG associations based on the "Initiative Transparente Zivilgesellschaft".
- We start the 2021 budget process. The budget team begins the first consultations on the 2021 budget.
- The Professional Service Project picks up speed. Up to 23 participants from various sectors take part. It becomes clear that we are setting up the project very broadly and that the timetable needs to be adjusted significantly. As part of the project mandate, it will be necessary to reorganize the organizational structure of the services.
- We decide to organize the coordination of the speakers under the responsibility of the IF in the future. In this way, we are opening a first, small-scale special purpose operation under the umbrella of the IF.
- The ECG Academy is to be developed in a separate project. Planned start: January 2021.
- We are complementing the ECG's strategic goals by setting milestones and developing indicators for each milestone, which will help us to measure the achievement of the goals.
- We want to support the growth of the movement in countries without ECG association presence. The FMC therefore decides that the IF may also accept people as supporting members. Ordinary membership is still only possible for associations. In this way we offer people without membership in a national association the possibility to use the association structures and the offers of the IF. As soon as a national federation is founded, membership in the IF ends. Such a member must then transfer its membership to the national federation.

#### Quarter 4 – October to December 2020

- We are discussing the improvement of our personnel policy. In particular, the international staff should be better supported in the future. In addition, there should be opportunities for information and exchange in international staff meetings.
- We welcome ECG-Belgium and ECG-Luxembourg as our tenth and eleventh full members.
- We decide to hold the 2021 Assembly of Delegates online. The format is to be slightly changed. The discussions of the proposals are to take place over several weeks in the run-up to the Assembly.
- The FMC in November decides to release 75% of the original budget of around €426,000. A working group is to develop proposals on the remaining 25% and on how to proceed with the budget process April 2021 at the latest.
- The FMC adopts a purchasing guideline according to ethical aspects.
- We close the successful year with a positive review of the year.

### Outlook 2021

At the end of 2020, the "Internationaler Verein zur Förderung der Gemeinwohl-Ökonomie e.V." (IPA) has fully handed over its tasks and activities to the IF. The task now is to build on the successful groundwork of the promoting association and to continue to support the growth of the movement.

For 2021, we continue to work on an improved budget planning process. We want to better align the planning horizon with our strategic goals. The strategy working group is to give us a detailed milestone plan for this.

Another focus in 2021 is the increasing internationalization of the movement. New associations have been founded in the USA, Mexico, Ecuador and Argentina, which we would like to support in their further development. In Latin America in particular, the ECG is developing in almost all countries. Here, it is important to integrate the new members into our processes and structures and to support their further development.

Furthermore, the further development of our internal organization is on the agenda. After three years, we want to reflect on the organizational structure of the IF and, from autumn 2021 onwards, think about how to improve our organizational structure. At the same time, the IF will start the common good balancing process for the years 2020/21.



### Source of funds 2020

The IF's income consists of donations of EUR 268,057.95 (previous year EUR 1,900.00), membership fees of EUR 105,621.01 (previous year EUR 2,600), and other income of EUR 422.63 (previous year EUR 0.00). Note: The 2019 financial year consisted of a short financial year. The IF had very few monetary business transactions for 2019 in the period from 18.11.19 to 12/31/.2019.

The majority of the income came from large donations. The largest donation was 106,500.00 EUR, the smallest 10.00 EUR.

The membership fee of the member associations is calculated according to the membership fee income of the participating associations. According to the calculation model, member associations pay a membership fee of 15% up to a membership fee volume of 5,000 EURO. For membership fees over 5,000 euros, the member associations pay 33% of their fee volume. In 2020, membership fees amounting to 105,621.01 EUR were paid to the IF.

Many thanks at this point for this excellent solidarity and cooperation.

### Use of funds 2020

In 2020, the IF had expenditures of 159,473 EUR, which were used in four areas for the objectives of the association.

63,755 EUR went into the area of public relations, mainly for press and media work. Other funds were used to support EU lobbying and the graphic design of working materials.


The ECG movement was supported with 49,394 EUR. This included, for example, supporting the project group to create an ECG label, promoting the audit tool and funding international fundraising. We spent EUR 27,369 on the provision and expansion of our IT infrastructure, which is now used by all ECG organizations worldwide.

The administration and management of our organization cost come to an amount of 18,955 EUR. A detailed report on the individual budget items can be found at the back of the annual report.

We would like to point out that the financial year was an atypical one in two respects. The IF only started with monetary activities on a significant scale in 2020, after the International Federation only became fully operational in November 2019. In the first half of the year in particular, business development was in the start-up phase. In the second half of the year, the IF gradually took over the standard activities from the International Promoting Association. We have largely refrained from mirroring the previous year's figures, as the comparison does not provide any relevant information.

Finally, we would like to point out that the IF was supported by a large number of volunteers active in the common good movement. Therefore, we would like to take this opportunity to again explicitly thank all the volunteers of the movement!

The public relations section includes all projects and services that inform the public about the Common Good Economy. This includes communication and press work, corporate identity and educational activities.

#### Project / Service goals:

- Establish the Economy for the Common Good as a relevant stakeholder in the European decision-making process.
- Establish contacts with key decision-makers in the various EU institutions regarding forthcoming EU legislative proposals.
- Developing and drafting position papers for the ECG on key legislative initiatives and EU policy issues
- Liaising and creating synergies with other NGOs and civil society organisations with similar interests and values as ECG.

#### **Process report:**

We spent the first months of the service contract elaborating the advocacy strategy of the Common Good Economy. The strategy has been finalised after several meetings with the ECG "core group", in which the priorities and objectives of ECG at EU level were discussed in more detail. As part of this strategy, Better Europe performed a stakeholder analysis as well as a scanning of the most relevant policies and legislative initiatives to the advocacy goals of the ECG. Based on this stakeholder map, we have drawn up a list of decision-makers to be contacted, which served as a basis for the ECG lobbying activity. In the first months of the collaboration, a first contact was established with important actors from the EU institutions and the NGO world, and meetings were set to introduce them to the concept of the common good economy. In addition, a meeting between Better Europe and the Matrix Development Team took place to better understand the group's concerns regarding the Due Diligence Initiative and to communicate these to the Brussels decision-makers. In addition, the "core group" was constantly kept up to date about important events and happenings in Brussels through daily or weekly reporting.

#### **Results:**

- Thanks to the intensive exchange between the core group and Better Europe, the key points of the advocacy strategy were successfully defined. Thus, the group incorporated in the advocacy strategy the most pertinent EU legislative initiatives to achieve the goals of the ECG at the EU level.
- Several documents were produced to support the advocacy work, which were also used for the subsequent drafting of various position papers.

The service / project is ongoing and will be continued in 2021.

Unfortunately, the COVID-pandemic led to financial insecurities at our main donors and was therefore also very challenging for the ECG fundraising. Nevertheless, we managed to increase in donations and memberships (see below).

Over the course of the year, we have successfully developed fundraising within the ECG to the next level. With our new quarterly distributed fundraising report every essential stakeholder is updated regularly and necessary actions can be undertaken. Our fundraising activities can now use a larger set of marketing tools including a comprehensive and reader-friendly annual report and a newly developed fundraising flyer to increase membership and donations. Additionally, we have developed the Code of Ethics for ECG fundraising and have received confirmation from the Delegates Assembly. Furthermore, we have successfully increased the fundraising footprint in the whole ECG movement. Based on the restructuring process in Austria, now the major ECG countries regularly exchange and align their fundraising activities. We developed a fundraising manual and share successfully used marketing materials. Additionally, we developed a series of workshops for ECG activists to strengthen their fundraising activities and make fundraising become part of their DNA.

Another essential set of activity concerns the digitalization of fundraising. We worked jointly with the national associations to assess our current membership process and identify improvement potentials to set free new fundraising resources. Additionally, we brought our donations into the 21<sup>st</sup> century by using a smart and digital donation tool on the international level.
